

# CHINA

China has historically been a stable and streamlined adoption program. Lifeline has had an adoption program in China since 2000. Lifeline has developed a wonderful network of guides and working relationship with the CCCWA .

## Adoption Requirements

- Adoptive parents must be 30 at time of dossier submission and no more than 50 years older than the adopted child.
- Couples married at least 2 years or single women can adopt
- China accepts families living in some countries as expats
- No more than 5 minors currently in the home

## Children Coming Home

- Children 18 months to 4 years with moderate to significant medical needs
- Children older than 4 with minor to moderate needs
- **Typical medical needs can include:**
  - Older children, Down syndrome, epilepsy, cerebral palsy, hearing and vision loss, blood disorders, heart conditions, cleft lip and palate, genetic conditions, developmental delay

## Travel

- 1 two week trip is required
- First week: In your child's province
- Second week: In Guangzhou

*Travel to China is currently suspended and travel protocols may change or include quarantines and extended time frames when reopened.*

## Matching Overview

- Families are eligible for matching with older children or children with significant medical special needs once their home study is completed
- Families waiting for young or minor to moderate needs children are eligible after their dossier is registered with the CCCWA
- Estimated timeline for the process is currently unknown due to the impact of COVID-19 on adoption process and travel.

# Process Timeline

## Application

The full application gathers in-depth information from families who wish to adopt from China. Your application is reviewed by our China team to affirm you are eligible for this program.

2 weeks

## Immigration

Throughout this 2 step approval process families will complete required paperwork and be fingerprinted for approval to adopt within certain parameters. Families then apply to immigrate a specific child to the US through adoption.

2-3 months

## Matching

Matching is dependent on the family's openness to age and need. Families can receive pre-approval for an older child with more significant needs earlier in the process. If waiting to match with a younger child, a family will receive files for review after submitting their dossier. LOA is the matching document issued by the CCCWA. Typically families travel 2-3 months after receiving LOA.

varies based on openness to age gender and sibling groups (can range from months to years)

## Post Adoption

Lifeline continues to provide post-adoption support to families long-term. In addition to a family's social worker, Lifeline's Counseling Team and educational services are helpful resources for families. Post adoption reports are due to China at 6 months and then annually for 1-5 years post adoption. Families will provide brief self-reports annually directly to the CCWA until the child is 18. Check-in calls and additional resources will also offered to support your family transition.

## Home Study

During this part of the process, social workers and families will talk extensively about various aspects of a family's life such as finances, health, home life, capacity for care, and overall well-being. In addition, families will be part of specific training for how to parent children from trauma backgrounds.

3 to 4 months

## Dossier

When all of the information from the home study and step one of immigration has been completed for the dossier, it will be sent to the program country for review. The China dossier is compiled of 13 items and is put together during the wait time for your Immigration Approval. Lifeline will notarize and authenticate the dossier documents for you.

2-3 months

## Travel

During your trip to China, Lifeline will assign you an English-speaking guide to assist in your adoption process, sight-seeing, and navigation around China. The first week will be spent in your child's province. You will have family day, your ADOPTION IS FINALIZED the day after family day and you will tour your child's orphanage. The second week will be spent in Guangzhou and you will complete important appointments and complete paperwork. There is some time for site-seeing and cultural experience during this trip.
